I (Please Print) _____ agree to enter into and sign this Season Pass Contract effective _____ (today's date) through December 31, 2021 or until all 12 rounds have redeemed.

All Season Passes must be paid in full at the rates defined below.

Twelve (12) Round Season Pass Walking \$550 or **Twelve (12) Round Season Pass Riding \$850**

All 2021 Allendale Country Club Season Pass holders will be entitled to the following benefits;

- **Online Tee Time** Booking window is Seven (7) Days in advance. This is two (2) days before public play. Season Pass holders booking a tee time by calling the Pro Shop will not be entitled to the Seven (7) day booking window and will be held to the Public reservation window of Five (5) days in advance.
- One (1) Range token per Nine (9) holes being played with the use of a 2021 Season Pass.
- Passes are severable into Nine (9) hole rounds.
- Season Pass Riding Pass holders will be entitled to a cart free of additional charge when utilizing the pass as the form of payment for any given round.

CONDITIONS OF THE AGREEMENT

Allendale tracks rounds used on a Season Pass via punch card. If the punch card is lost the pass will not be replaced and any additional rounds on the pass will be forfeited.

Season Passes are not transferable and can only be used by the Season Pass holder assigned to the pass. Guest (Non-pass holders) playing with a Season Pass holder will be required to pay the Public Tee Time rate and Cart Fee, if applicable.

Allendale Country Club will not be held liable for any Government regulations or directives that prohibit Allendale Country Club's ability to provide services including Golf, Range, Cart usage and Facility Access, etc. Allendale Country Club will also not be held responsible for any decisions Allendale makes, at its sole discretion, in the safety interests of its Staff, Members or Guests.

DRESS CODE

All golfers must wear collared shirts and appropriate bottoms. Tee shirts and Jeans are not permitted. If a player is not appropriately attired, he or she will not be allowed to play on the course, unless a change of attire is obtained.
