### The Agreement

I understand that by signing below, I am financially obligated to pay all dues, Food and Beverage Minimums and miscellaneous Member Golf Account Charges/Fees, associated with my yearly membership regardless of any unforeseen circumstances that may occur throughout the Membership year. Any requests for refunds are required to be made to the board of directors in writing and subject to board of director approval at the board's sole discretion.

Monthly billing statements will be sent via email, however, not receiving these statements will not be viewed as grounds for missing a scheduled payment as defined by the schedule below. I understand and agree that if my monthly invoice is not paid in full by the first day of the new billing cycle a 10% non-refundable late fee will be added to my next statement and understand that my account may be suspended, and golfing or restaurant privileges revoked until past due balances are corrected.

I understand that if my Account becomes 45 days past due, my membership and/or food privileges will be revoked from the Club and turned over to an attorney for collections. In the event of collections, I would be responsible for all expenses incurred by the club to include outstanding balance and attorney fees. To be reinstated I must settle all debts and fees.

**Food and Beverage Billing**

Monthly Food and Beverage minimums are in effect March 2023 through September 2023. Minimums will be set at \$60 per month for Singles, Intermediate Plus, and Intermediate Membership Categories and \$90 per month for the Family Membership Category. No Food and Beverage Minimums are applicable to Student or Junior Membership Categories.

During these Seven months, Members will be required to charge their respective Food and Beverage Minimum purchases to their Member Golf Accounts. If the monthly Food and Beverage Minimum (\$60 or \$90) is not satisfied, in full, during the required month, then the unspent balance will be charged to the Member's Golf Account at the end of that month.

Food and Beverage Minimums are to be used within the corresponding month, (March minimum must be entirely used in March). Each month will start off with the required minimum of \$60/\$90. Applicable Food and Beverage Minimum purchases are any Food and/or Beverage item purchased in the Restaurant, Patio Bar/Restaurant, Pro Shop or Beverage Cart and must be charged to the Member Golf Account to satisfy the monthly Food and Beverage Minimum requirement (ex. Food or Beverage Purchases paid in the form of Cash, Check or Credit Card will not be applied to the monthly Food and Beverage Minimum requirement).

Members will be provided lockers and bag storage, as requested, at the Members risk. Allendale is not liable for any loss or damage to Members personal property for any reason whatsoever.

**Golf Cart Privileges**

The Lessee agrees to abide by all of the Rules and Regulations on the use of a Golf Cart. Lessee agrees to keep vehicle in the same condition as when received. It is expressly understood and agreed that no right of action whatsoever shall accrue to the Lessee for damages of any kind whatsoever, whether to person and/or property, arising from the use of, operation of, or in any way connected with the property of any part thereof, from whatever cause arising. Lessee agrees to hold all parties free and harmless from all such damage.

Lessee expressly acknowledges personal liability to pay Lessor costs to repair all damages to said property and Lessor's costs including attorney fees incurred in collection of payments due from Lessee hereunder. The full agreement between the Lessor and Lessee is contained herein, and time is made of the essence of this agreement. The receipt of all above-described property, in good order and repair is hereby acknowledged by Lessee.

Allendale Country Club will not be held liable for any Government regulations or directives that prohibit Allendale Country Club's ability to provide member services including but not limited to Food, Beverage, Golf, Bag Storage, Range and Facility Access, etc. Allendale Country Club will also not be held responsible for any decisions Allendale makes, at its sole discretion, in the safety interests of its Staff, Members or Guests.
